Environmental sustainability

PoMC has taken a proactive approach to managing land, sea and air environment risks as a vital and responsible component of modern business thinking and practice. See our environmental initiatives below.

Addressing climate change

PoMC's Climate Change Strategy involves programs to reduce energy consumption and increase the environmental efficiency of PoMC's activity as well as measuring and reporting on climate change initiatives.

Water and energy savings

PoMC's Water & Energy Management Strategy is aimed at identifying and implementing opportunities for conserving water and energy wherever possible, including water harvesting.

Managing contaminated land

PoMC has a Contaminated Land Management Strategy to identify, assess and manage areas of land in the port precinct contaminated by poor past environmental practices as far back as 150 years ago. This program is delivered in consultation with the Environment Protection Authority (EPA).

Safety and Environment Management Plan (SEMP)

PoMC's SEMP is a best practice program to identify and mitigate safety and environmental risks across the port. PoMC's Safety and Environment Management System is aligned to ISO 14001 – Environmental Management Standard and AS4801 – Occupational Health and Safety Management Standards.

Social contribution

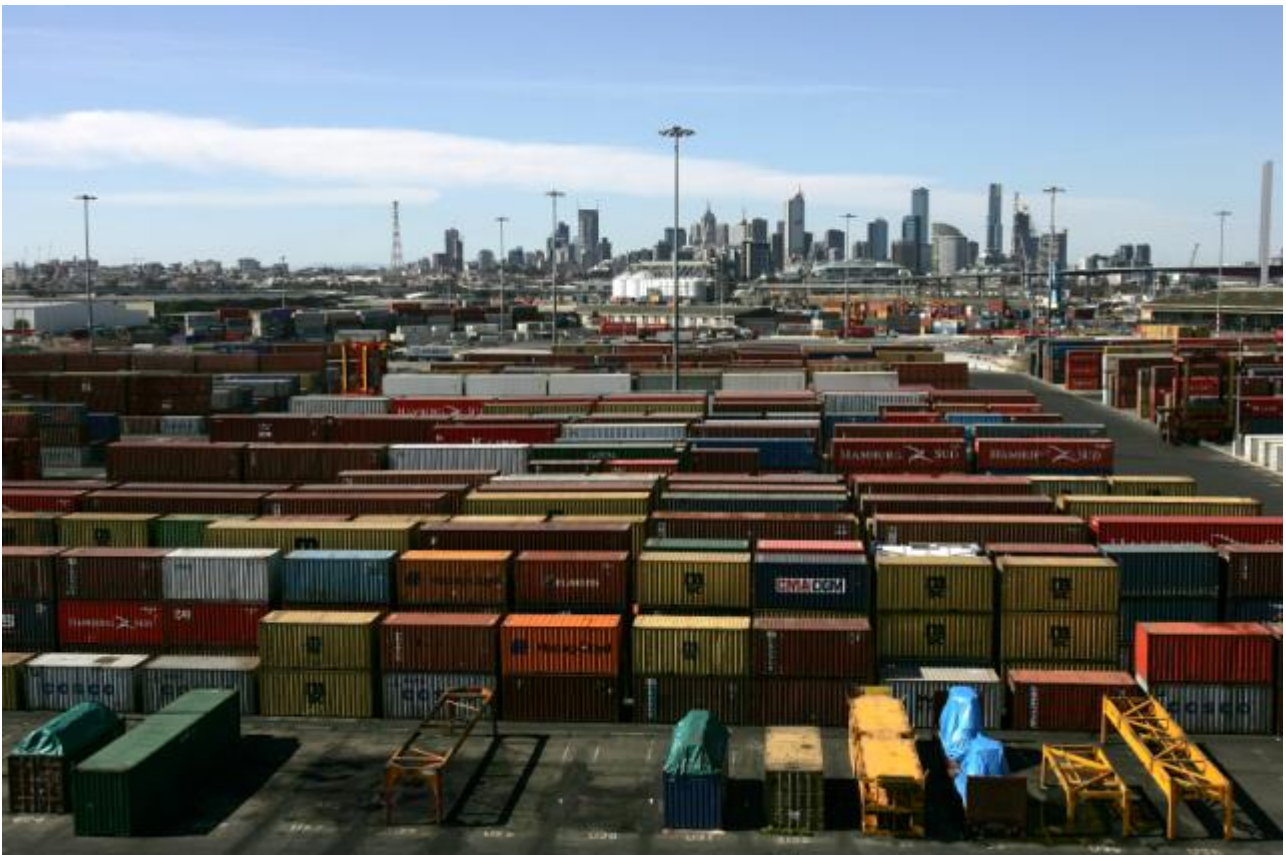
Victoria's growing population is the key driver of growth in trade through the Port of Melbourne.
