**Glossary**

**Revenue tonnes** - a quantity measure based on the greater of weight in mass tonnes and volume in cubic metres

**TEU** - a twenty foot equivalent unit, the international measure for standardizing container throughput numbers.

**Motor Vehicles** - comprises of new motor vehicles, second hand motor vehicles and transport equipment.

**Bass Strait direct** - domestic cargo only, shipped direct from Melbourne to Tasmania, or Tasmania to Melbourne.
